Prior to her work with the MTC, Ms. Sicilian served as Director of Policy and Research, and then General Counsel, for the Kansas Department of Revenue.

Before working in the tax area, Ms. Sicilian worked in public utility regulation, serving as Chief of Economic Policy and as Assistant General Counsel for the Kansas Corporation Commission.

Recognition, Publications, and Speaking

Ms. Sicilian is nationally recognized for her work in state tax. In 2023, KPMG's state and local tax practice presented Ms. Sicilian with a Legacy Stewardship Award for Leading with Impact. In 2022, Ms. Sicilian was recognized by the Bloomberg Tax Advisory Board with the Franklin C. Latcham Award for Distinguished Service in State and Local Tax. In 2013, the Multistate Tax Commission presented Ms. Sicilian with the Paull Mines Award for Outstanding Contribution to State Tax Jurisprudence. Also in 2013, Tax Analysts – State Tax Notes named Ms. Sicilian a finalist for its 2013 Person of the Year, citing her as "one of the most influential legal thinkers in the field."

Ms. Sicilian has been appointed to serve on a variety of advisory and deliberative boards; is a frequent writer, instructor, and speaker on state tax topics; and has authored many briefs on matters before State Supreme Courts and the U.S. Supreme Court. Her articles have appeared in various publications, including Bloomberg Tax, State Tax Notes, The Tax Lawyer, Proceedings of the New York University Institution on State and Local Taxation, and the Journal of Multistate Taxation. Her publications include co-authorship of the state corporate income tax chapter for CCH, authorship of the corporate income tax chapter for State Business Taxes — a periodical from Law Journal Press, and a book chapter for The Allocation of Multinational Business Income: Reassessing the Formulary Apportionment Option — part of a series on international taxation from Wolters Kluwer.
